Application to become a Solar Shares Participant

NH Solar Shares is a community solar PV installation with 100% of the proceeds going to our participants, who each receive a credit of \$23-\$32 every month on their electric bills depending on the solar generation. **NH Solar Shares** is open to individuals and families who are receiving NH Fuel Assistance or Electrical Assistance (EAP), or living in low-income housing, including recently built Habitat for Humanity homes. Our goal is to welcome low-income families so they too benefit from the cost savings and environmental benefits of solar energy, while also contributing to healthier communities.

Residents of the following towns are eligible to participate: *Plymouth, Campton, Warren, Wentworth, Rumney, Center Harbor, Holderness, Sandwich, Moultonborough*

- Program participation lasts for two years.
- There is no fee, ever, to participate.
- Participants will be invited to our **Solar Shares Meet Ups** where they will learn how solar panels work, and get tips on how to conserve energy to further reduce their home's fuel and electric bills. **Meet Ups** also include activities to help maintain the Solar Shares sites such as preparing edible gardens and clearing brush.
